1. Please provide your trust policy for borderline personality disorder diagnosis and treatment.

Essex Partnership university Trust does not hold a single policy relating to the personality disorder diagnosis. There are a number of Trust policies that outline delivery and inform practice.

These include service operating policies such as the Standard Operating Procedure Personality Disorder & Complex Needs MDT (attached).

Service delivery and practice is also informed by national policies such as the NICE guidelines on Personality Disorder: Recognition and Management (attached) and the NIMHE Competencies Framework (attached).

2. How much funding is received for the care of borderline personality disorder and how is this money spent?

The Essex Partnership University Trust does not currently hold this information, in the format requested, because our financial records cannot be broken down to the level requested.

3. How many adult patients are there within the trust with a diagnosis of borderline personality disorder?

8. Does the trust provide dialectical behaviour therapy? If so, please provide the numbers of patients/ service users who have used this service. If not, is there a plan to implement this treatment? The Trust delivers both group and individual DBT. The below table outlines group & individual DBT offer for the periods April 2022 to March 2023 and April 2023 to August 2023. The data reflects activity in the Adult Community Psychology services which are the main providers of DBT. The second table illustrates DBT provision by area.

9. How many suicides of patients with borderline personality disorder have there been each year?

We can neither confirm nor deny whether some of the information you have requested is held by the Trust in its entirety. This is because the information requested is not held in an easily retrievable format, but may be recorded in individual records. In order to confirm whether this information is held we would therefore have to individually access all records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for.

10. How many complaints have been lodged in relation to borderline personality disorder treatment?

There have been 21 complaints lodged between 2019 and 2023 in relation to BPD and EUPD.

Section 12 (Exemption where cost of compliance exceeds appropriate limit):

- Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.
- (2) Subsection (1) does not exempt the public authority from its obligation to comply with paragraph (a) of section 1(1) unless the estimated cost of complying with that paragraph alone would exceed the appropriate limit.
- In subsections (1) and (2) "the appropriate limit" means such amount as may be prescribed, and different amounts may be prescribed in relation to different cases.
- (4) The Secretary of State may by regulations provide that, in such circumstances as may be prescribed, where two or more requests for information are made to a public authority—
 - (a) by one person, or
 - (b) by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign, the estimated cost of complying with any of the requests is to be taken to be the estimated total cost of complying with all of them.
- (5) The Secretary of State may by regulations make provision for the purposes of this section as to the costs to be estimated and as to the manner in which they are to be estimated
