Like other NHS organisations nationally, we are experiencing an increased demand for our services following the impact of the COVID-19 pandemic and other social factors. We have comprehensive action plans in place to reduce out of area placements and ensure that all admissions to our wards are purposeful and appropriate for patient needs.

The Trust is working closely to new national guidance published by NHS England, ensuring that people are only admitted to our inpatient wards when they need treatment or intervention that can only be provided in hospital and it is most suited to their needs. We know hospital isn't, for some patients, the best environment to aid recovery and many benefit from the enhanced routine and crisis care and support provided by our community teams. We have also introduced new senior clinical patient flow leads to help ensure patients receive the right care, in the right place at the right time and spend less unnecessary time in hospital.

However, like all healthcare providers, we have a limited number of beds available so, at times, working with our partners, we have to offer alternative care to ensure patients receive the timely and appropriate support they need. This can be admission to another hospital or care provider, taking into account the views and needs of patients and their loved ones and carers and putting patient safety first.
