The Impact, Productivity & Value of Community Services

Context cont'ed

- Systems that invested more in community care saw 15% lower non-elective admission rates and 10% lower ambulance conv. rates (statistically significant)***
- Currently no relationship between the amount invested by NHS organisations in community care and their population community care needs***
- Current lack of national guidance/prioritisation on
 - Core service offer and investment shift expectations
 - System impact measures, productivity or value quantification of community services
- New MSECC contract reference, but no agreed mechanism for investment shift
- Longer term need for Strategic Review of MSE wide need and model of community services

The Impact, Productivity & Value of Community Services

MSECC

- Development of single document, aiming to:
 - Demonstrate our system impact and productivity
 - Demonstrate value (productivity + impact = value)
 - Demonstrate delivery on our contributions to system financial recovery
 - Presents impact on quality
- Internal and external purpose incl. Accountability Framework (AF) review meetings
- Key metrics in relation to
 - Community & stroke beds, Virtual Wards, Urgent Community Response Team and community nursing
- Presents a single currency model (Occupied Bed Days saved)
- Data updated on a monthly basis, aligned to the AF reporting cycle.
- Active developing document, with further planned iterations to follow
