Information Requested:

I would like to request the following information under the Freedom of Information act

1. Does your trust currently use born worn video cameras. (Clarification: I am referring to use of cameras by mental health staff i.e. not security personnel. If you have previously used, or are planning to begin using body worn cameras please consider the following questions to ask about former or planned uses)

The Trust nursing staff have access to the use of body worn cameras on every mental health inpatient ward.

- 3. Please provide copies of equality impact assessments relating to use of body worn cameras. If this has not been completed, please state.

- 5. Please state which mental health services these are approved for use in (e.g. seclusion, adult wards, and CAMHS wards)

- 6. Please provide details of equipment used: number of cameras held by the trust and supplier of these.

The Trust have 226 cameras supplied by Reveal Media Ltd.

- 7. Please provide details of where video footage is saved and how long this is retained. Video footage from Body Worn Cameras is saved on a secure platform, which only authorised EPUT staff, have access. Video footage is retained for a 60 day period, with the exception of those containing material related to an incident, which is retained for a period of two years.
- 8. Please provide details of consent processes for use of born worn cameras. There is implied consent through the inpatient admission process. There is also signage across all sites where Body Worn Cameras are being used.
- 9. Please provide details of complaints relating to born worn cameras usage since Jan 2019. ≤5



Please note that the trust's policy is not to provide patient or staff numbers, where the response is less than or equal to five (≤5) as it would potentially allow identification of the individual patient/staff and would therefore be personal data.

The trust considers that release of that information would breach GDPR/DPA18 principles on the grounds that it would not be fair in all the circumstances. This information is therefore exempt under section 40 of the FOI Act 2000.

10. Please provide details of where body worn footage has been submitted as part of criminal/court proceedings since Jan 2019.

We can neither confirm nor deny whether some of the information you have requested is held by the Trust in its entirety. This is because the information requested is not held in an easily retrievable format, but may be recorded in individual records. In order to confirm whether this information is held we would therefore have to individually access all records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for.
