The Estates department does not have a separate budget to purchase CCTV systems. Any funding is obtained via a capital bid through the Trust governance groups, if agreed, a market tender process is undertaken and completed via a capital project.

The annual budget for Estates & Facilities is c. £33.3 million (based on Month 10 year-to-date, January 2024).



23. What % of the estates budget is associated with IT systems for the management and running of the building and trust facilities (e.g., CCTV systems)?

We have a contract with Minerva who maintain and manage our systems. The maintenance of the CCTV is £13,355 per annum, this is the cost of the maintenance contract. The percentage of CCTV maintenance cost of the Estates budget is 0.04%.
